

## **CSMIA Enhances Southeast Asia Connectivity, Marking 19% Growth in Passenger Traffic in 2024**

- *Witnessed over 14,000 Air Traffic Movements (ATMs) in 2024, with 1,295 in December 2024 to Southeast Asia (vs. over 11,000 Air Traffic Movements (ATMs) in 2023, with 1,173 in December 2023).*
- *Flights to Indonesia, Malaysia, Thailand, Singapore, and Vietnam, boosting regional international connectivity*
- *Top destinations in Southeast Asia: Singapore, Bangkok, and Kuala Lumpur*

**Mumbai, 25 March 2025:** As Southeast Asian (SEA) countries ease visa regulations and expand flight options to attract Indian travellers, Chhatrapati Shivaji Maharaj International Airport (CSMIA) remains at the forefront of this travel surge. In 2024, CSMIA recorded 2.51 million passengers flying to SEA, marking a 19 percent year-on-year growth from 2.10 million in 2023. This steady rise reinforces its position as a key international gateway, offering seamless connectivity, operational excellence, and an enhanced travel experience. With increasing demand for travel to Thailand, Indonesia, Vietnam, and Malaysia, CSMIA continues to strengthen regional access, meeting the evolving needs of global travellers.

Southeast Asia remains a pivotal market for CSMIA, with strong connectivity to five major countries – Indonesia, Malaysia, Thailand, Singapore, and Vietnam offering a total of 133 weekly flights. The steady expansion of services, coupled with eased visa regulations for Indian travellers has further bolstered demand.

Among the most travelled routes, Singapore, Bangkok, and Kuala Lumpur emerged as the top three destinations, witnessing the highest passenger traffic. Leading airlines in the Southeast Asian sector include Singapore Airlines, Air India, IndiGo, Thai Airways, and Malaysia Airlines.

CSMIA and SEA surpassed 14,000 ATMs in CY 2024, with December recording an exceptional 1,295 arrivals and departures. With simplified visa processes expected to drive further demand, CSMIA remains poised to exceed expectations, offering seamless travel, enhancing passenger services and setting new industry benchmarks in international travel.
